

#### **ORDINANCE NO. 3999**

#### AN ORDINANCE ADOPTING THE CITY OF ANACORTES CAPITAL FACILITIES PLAN (CFP) FOR THE 6-YEAR PERIOD 2022-2027

Section 1. The Growth Management Act mandates development of a capital facilities element consisting of a six-year financing plan [RCW 36.70a.070-(3)].

Section 2. The City of Anacortes Comprehensive Plan is hereby amended to adopt the 2022-2027 Capital Facilities Plan, which is attached hereto. Adoption of the 2022-2027 Capital Facilities Plan will replace the 2021-2026 Capital Facilities Plan.

Section 3. The total estimated expenditures/revenues for each major category and the aggregate total for all such categories combined are summarized and set forth as follows:

Parks	\$4,710,000
Fiber	\$12,332,226
Fire/EMS	\$8,399,251
Waste Water	\$65,927,000
Solid Waste	\$231,700
Storm	\$1,409,000
Transportation	\$96,113,100
Water	\$30,742,400
Total	\$250,090,677

Section 4. Effective date. This Ordinance shall take effect from and after five (5) days after its passage and publication, as required by law.

# **CONSUMER DISCLOSURE**
