ORDINANCE NO. 4049



AN ORDINANCE AUTHORIZING AN INTERFUND LOAN BETWEEN THE EQUIPMENT RENTAL FUND AND THE GENERAL FUND

WHEREAS, the Fire department resides within the General fund, and the City has recently purchased the building that Station 3 operates out of for a cost of \$1,857,773, and

WHEREAS, the City intends to issue a long term debt instrument to cover the cost of that purchase but in the interim would like to reimburse the General Fund for that purchase to bolster the operating cash for day to day operations, and

WHEREAS, the Equipment Rental fund has sufficient cash on hand to make an interfund loan to the General fund and still retain sufficient cash to not affect its ability to continue operations.

NOW, THEREFORE THE CITY COUNCIL OF THE CITY OF ANACORTES DOES ORDAIN AS FOLLOWS:

- **Section 1.** The Equipment Rental Fund is authorized to loan the General fund \$1,857,773 on a term of up to five years.
- **Section 2.** The loan amount will be assessed at an interest rate which is equal to the 5-year Treasury rate, which is currently 3.63%. Payments will be due on December 31st of each year. Payoff of the entire balance can be made at any time. If payoff is made in a partial year, a prorated amount of interest will be charged.

EFFECTIVE DATE. This ordinance shall take effect from and after five (5) days after its passage and publication as required by law.
