

ORDINANCE NO. 4050

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ANACORTES, AUTHORIZING ACCEPTANCE OF A RESTRICTED DONATION TO THE CITY OF ANACORTES

WHEREAS, the City of Anacortes authorizes acceptance of donations through AMC chapter 3.10, and

WHEREAS, the City would like to accept donations up to \$1,600,000 from the Anacortes Skate Park Improvement Project to be used in accordance with the donative intent of providing funding to design, construct, finish and maintain a new skatepark by the City of Anacortes Parks and Recreation department; and

WHEREAS, the amount of this restricted donation requires acceptance by City Council.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF ANACORTES DOES ORDAIN AS FOLLOWS:

- Section 1. The City of Anacortes hereby accepts donation of up to \$1,600,000 by the Anacortes Skate Park Improvement Project to be used for design, construction, completion, maintenance, and related expenses for the new skatepark to be constructed at the location of the current Ben Root Skate Park; and
- Section 2. This ordinance shall take effect upon its passage, approval and publication in the manner required by law.
