

ORDINANCE NO. 4056

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF ANACORTES, AUTHORIZING ACCEPTANCE OF A RESTRICTED DONATION TO THE CITY OF ANACORTES

WHEREAS, the City of Anacortes authorizes acceptance of donations through AMC chapter 3.10, and

WHEREAS, AMC 3.10.030 (B)(2) directs that restricted donations exceeding \$10,000 must be accepted by City Council, and

WHEREAS, the City would like to accept a donation of up to \$65,000 from the Senior Activity Center Foundation whose donative intent is to provide funding to design, construct, finish and maintain, a new outdoor pavilion, which will be built and maintained by the City of Anacortes Parks and Recreation department.

NOW THEREFORE, THE CITY COUNCIL OF THE CITY OF ANACORTES DOES ORDAIN AS FOLLOWS:

- Section 1. The City of Anacortes hereby accepts donation of up to \$65,000 by the Anacortes Senior Activity Center Foundation to be used for construction, completion, maintenance, and related expenses for a new outdoor pavilion to be constructed at the location of the current Senior Activity Center; and
- Section 2. This ordinance shall take effect upon its passage, approval and publication in the manner required by law.
