ORDINANCE NO. 4065

An ordinance of the City of Anacortes, Washington, updating Title 13 Division IV of the Anacortes Municipal Code to eliminate the ambulance service fund and allow City Council to adopt a schedule of fees in the unified fee schedule for ambulance services.

WHEREAS, The ambulance services fund, created by Section 13.54.100 of the Municipal Code, is no longer necessary.

WHEREAS, The City has entered into a contract with Skagit County to provide emergency medical services within the county.

WHEREAS, The City is no longer required to maintain a separate fund for ambulance services.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF ANACORTES, WASHINGTON, DOES HEREBY ORDAIN THAT:

<u>Section 1.</u> The Anacortes Municipal Code is hereby amended as follows: Repealing Section 13.54.100, which creates the ambulance service fund.

<u>Section 2.</u> Section 13.54.110 is hereby amended as follows: The City Council may, by resolution, adopt in the city unified fee schedule, a schedule of fees and charges for ambulance services.

<u>Section 3.</u> The ambulance service fund is hereby eliminated and shall become part of the general fund.

<u>Section 4.</u> This ordinance shall take effect and be in force 5 days after its passage and publication as required by law.
